Session Capacity



Conduct Policy

Disclosure Policy

The American Cleft Palate Craniofacial Association (ACPA) has adopted the following Disclosure Policy in compliance with the Accreditation Council for Continuing Medical Education (ACCME) Standards for Integrity and Independence in Accredited Continuing Education (Released December 2020), the American Speech-Language Hearing Association's (ASHA) Continuing Education Board's Requirements, and the requirements of the American Nurses Credentialing Center's (ANCC) Commission on Accreditation.

ACPA requires that all individuals involved in planning or presenting (e.g., faculty, abstract authors and co-authors), or any other person in control of content for accredited continuing education activities sponsored or jointly sponsored with ACPA must disclose all financial relationships with ineligible companies.

The individual must disclose all financial relationships with ineligible companies which have existed within the last 24 months, by providing the name of the ineligible company and



the nature of the financial relationship. An ineligible company is any entity whose primary business is producing, marketing, selling, re-selling, or distributing healthcare products used by or on patients. For specific examples of ineligible companies, visit accme.org/standards. There is no minimum financial threshold; all financial relationships, regardless of the amount, with ineligible companies, must be disclosed. All financial relationships must be disclosed, regardless of the potential relevance of each relationship to the education. Examples of financial relationships include employee, researcher, consultant, advisor, speaker, independent contractor (including contracted research), royalties or patent beneficiary, executive role, and ownership interest. Individual stocks and stock options should be disclosed; diversified mutual funds do not need to be disclosed. Research funding from ineligible companies should be disclosed by the principal or named investigator even if that individual's institution receives the research grant and managed the funds.

ACPA's Disclosure Policy also requires disclosure of all non-financial relationships that might bias an individual including personal, professional, political, institutional, religious, or other.





MAIN (300) LEVEL






